
JSH envisions mobilizing an equitable and effective health system that increases access to high-quality services, builds safe and healthy communities, and enables improved health outcomes for all.

Health Service Delivery



PORTFOLIO

USAID eSCMIS PROJECT

JSH is implementing the five-year USAID Electronic Supply Chain Management Information System (eSCMIS) project. JSH is the prime partner in this project and will work in partnership with JSI and the Churches Health Association of Zambia (CHAZ).

Aim: create an efficient and reliable health supply chain using a next-generation logistics management information system. The project is funded by the United States Agency for International Development (USAID).

Through the USAID eSCMIS project, JSH is transforming the Electronic Logistics Management Information System (eLMIS) into a next generation system. This undertaking is in close collaboration with the MOH, ZAMMSA, CHAZ and other key supply chain partners.

Vision: a state-of-the-art open source digital platform that provides end-to-end real-time supply chain visibility to support improved decision-making, accountability, fiscal responsibility, and local ownership, leading to a more efficient and sustainable supply chain, a more effective health system, and better health outcomes.



USAID ZAMBIA ACCESSIBLE MARKETS FOR HEALTH (ZAM-HEALTH)

The USAID Zambia Accessible Markets for Health (ZAM-Health) Activity is a five-year project that aims to sustainably expand the availability and accessibility of high-quality health products and services in the private sector, improve health knowledge, and increase the adoption of healthy and health-seeking behaviors. The program will employ both supply and demand-side interventions working in partnership with the private sector (for-profit and nonprofit entities) as well as the Government of Zambia.

USAID ZAM-Health is implemented by JSH in partnership with JSI Research & Training Institute, Inc. (JSI), Media 365 and PharmAccess. The consortium will apply a market facilitation approach to coordinate, catalyze, and harness the private sector to reach priority populations with health products, services and information.



USAID CHEKUP II

The USAID Controlling HIV Epidemic for Key and Underserved Populations (CHEKUP II) is a USAID Zambia activity that is designed to address the needs of people living with HIV and those most at risk of acquiring HIV, while contributing to HIV mitigation and epidemic control. Specifically, CHEKUP II is improving the health outcomes of priority and key populations in Zambia with the highest HIV burdens and in high HIV burden provinces, by preventing new HIV infections and ensuring that all those that are infected are identified, diagnosed, linked to treatment, and virally suppressed. As the prime recipient, John Snow Health Zambia (JSH) will implement activities aimed at achieving these objectives, with John Snow Research & Training, Inc. (JSI) and Media 365 as sub-partners.



PRUDENTIAL COVID-19 RELIEF FUND

Prudential Life Assurance Zambia has, through a Corporate Social Responsibility (CSR) Fund, donated US\$40,000 for the development and dissemination of communication materials on COVID-19 to traditional leaders in Zambia.

JSH, in partnership with USAID DISCOVER-Health and the Ministry of Health, supported Prudential in the dissemination of correct information about COVID-19 to rural communities through the vast network of traditional leaders and chiefs in Zambia. The project included printing COVID-19 information, education and communication materials in all seven major local languages for distribution through traditional leaders to help reinforce COVID-19 messaging and adoption of preventive behaviors and timely access to care. The aim was to impact around 5 million Zambians in more than 100 chiefdoms.



ZANZIBAR eLMIS FACILITY EDITION ROLL-OUT

In October 2014, JSI through the USAID | DELIVER PROJECT successfully deployed OpenLMIS in Zanzibar as a pilot under the local name eLMIS. By February 2015, the system went live in all districts, and the sensitization training for all management teams was completed in June 2015. Currently the system is running successfully in all facilities in Chakechake District. Orders and shipments of health commodities are integrated between eLMIS and mSupply, the warehouse management system at the Central Medical Store.

Sponsored by the Global Fund to Fight AIDS, Tuberculosis and Malaria through the Ministry of Health of Zanzibar, JSH is subcontracted by JSI to enhance the Tanzania eLMIS in preparation for full deployment of eLMIS facility edition in Zanzibar.

SRH SUPPLY CHAIN ROADMAP

Zambia is focused on addressing policy barriers and hindrances unfavorably affecting the delivery of sexual and reproductive health services for young people. One of the main objectives is to scale up admittance to family planning through an assortment of contraceptive methods and services in all marginalized and indigenous communities.

JSH was subcontracted by JSI, the prime contractor, to undertake data collection and analysis of the sexual and reproductive health commodity supply chain with the aim to use the data towards improving supply of sexual and reproductive health commodities to all parts of the country.

The FP Access Program 2020/ SRH Supply Chain Roadmap was funded by the Bill and Melinda Gates Foundation.



ABSA COVID-19 GRANT

ABSA Bank Zambia Limited (ABSA) collaborated with John Snow Health Zambia Limited (JSH) on COVID-19 activities in Zambia through the USAID DISCOVER—Health project, which is being implemented by JSI Research and Training Institute Inc., (JSI R&T) JSH's affiliate organization.

The symbiotic partnership began funding the procurement of essential COVID-19 products. ABSA enlisted the help of JSH to obtain essential COVID-19 products. JSH provided technical support in the areas of procurement, finance, and an in-depth knowledge of health-care delivery.

Aim: to fulfil a dual mandate by supporting ABSA's corporate social responsibility efforts while also enhancing JSH and JSI R&T's efforts to improve health outcomes for all.

In collaboration with the ABSA Zambia team, JSH obtained essential COVID-19 commodities for the prevention, treatment, and management of the pandemic in Zambia. The Zambian people are the initiative's beneficiaries



COVID-19 END USER MONITORING

UNICEF supported the Zambian Ministry of Health (MOH) to respond to the COVID-19 pandemic in Zambia by purchasing essential medicines, personal protective equipment, and IPC products to help the Zambian government combat the rising number of infections and maintain Reproductive, Maternal, Newborn and Child Health services in hospitals and primary health care facilities.

MOH established an end-user supplies monitoring assessment, funded by UNICEF and conducted by John Snow Health (JSH), to ensure that supplies and medicines reached the intended beneficiaries and were used properly.

The assessment included end-user monitoring of COVID-19, essential medicine and equipment supplied to health facilities, documentation of logistics processes, and identification of potential gaps and challenges in order to develop supply chain interventions.

The six-month activity was managed collaboratively with UNICEF, MOH, and Zambia Medicines & Medical Supplies Agency, with JSH serving as the main contractor.



NEW HORIZONS COLLABORATION

The New Horizons Collaborative (NHC) has been working in 11 African countries, including Zambia, for over six years to improve children's access to second- and third-line ARVs.

NHC seeks to expand program support in Zambia. Part of the preparation for this support was NHC's work with the Ministry of Health and JSH to assess current program impact, increasing donor supply chain visibility and identifying gaps and difficulties for improved third-line ART management.

As a baseline, these activities included:

Monitoring key supply chain performance indicators (KPIs) in service delivery points (health facilities) involved in the management of third-line pediatric ART goods and/or customers,

A comprehensive country assessment of supply management operations, forecasting and quantification, warehousing, distribution, information systems, and so on.

The findings of these activities should aid the Ministry of Health and its ART partners in developing a collaborative technical support strategy for 3rd line ART therapy.
